






Chamber Legislative Priorities

Chamber Legislative Priorities

Issue: Reliable and Affordable Energy

- <u>Cost-of-Service Rates</u> Support the implementation of cost-of-service rates as required by PA 286 of 2008.
- New Power Plants Support efforts to ensure that new clean coal and nuclear plants can be fairly evaluated. New base-load plants should not be held up to political agendas. The DEQ must review permits in a timely fashion.
- <u>RPS</u> Support implementation of the new Renewable Portfolio Standard PA 295 of 2008. Lawmakers must avoid increasing renewable percentages.

Building New Generation - Recap

- In 2007 the Public Service Commission put out a report called the "21st Century Energy Plan." The plan recognized the need for renewable energy, base-load power, and more energy efficiency.
- In January of 2008 the House of Representatives puts together 3 workgroups: 1) Building New Generation
 2) Renewable Portfolio Standards 3) Energy Efficiency
- In Fall of 2008 Public Acts 286 and 295 signed into law by Governor – Accomplish Goals of 21st Century Report and House Work Group

Building New Generation

- Feb 3 Granholm State of State address says: "We must find alternatives to prevent coal plants from spewing dirty emissions into the air."
- Issues Executive Directive 2009-02 Places "Moratorium" like conditions on Coal Plants. Requires DEQ to determine if Energy is needed and if alternatives can be provided before issuing permit air permits.
- March 2009 74 members of the Michigan House send a letter to the Governor expressing their dissatisfaction with her actions to delay coal plants.

Building New Generation

- In July Speaker Dillon and Rep. Mayes send letter to DEQ stating they have been 730 days in reviewing air permit. Letter says permit should be acted upon by November 1.
- In August the DEQ says there is no deadline for the air permit.
- In September PSC develops report questioning need for more power.
- End result: DELAY, DELAY, and more DELAYS from state government.

Renewable Portfolio Standards

PA 295 of 2009 Requires 10% RPS by 2015

Provides Funding Mechanism - Per Meter Charge

Residential \$3.00/month

Commercial and Small Ind. \$16.58/month

Primary Industrial \$187.50/month

 Balanced the needs to diversify energy sources with the need to keep electric rates competitive

Renewable Portfolio Standards

- 23 House Democrats announce support to raise RPS to 30% by 2025. (ReEnergize Michigan Coalition)
- Issues remain with RPS
 Reliability
 Siting/Zoning
 Transmission
- Let's give our law a chance to work before making dramatic changes.
